On-line registration including Edit/Modification of Application by candidates and Payment of Application Fees (only Online): 15.01.2023 to 31.01.2023

- Date of Online Preliminary Exam.: 17.02.2023 & 20.02.2023 (tentative).
- Date of Online Main Exam.: 18.03.2023 (tentative).
- Age (As on 01.01.2023): Minimum Age shall be 21 years (completed) as on 01.01.2023. Maximum age shall not be more than 30 years (candidates must have been born not earlier than 02.01.1993 and not later than 01.01.2002 both days inclusive only are eligible).
 - Relaxation of Upper age limit: SC/ ST 5 years, OBC 3 years, Persons With Disabilities 10 years, Others as per rules.
- ■ Educational Qualifications (As on 01.01.2023): Bachelor's Degree in any discipline from a recognized Indian University/Institution.
- ☐ Application Fees/ Intimation Charges: Candidates will have to make the payment of Application Fees/Intimation Charges through the On-Line Mode as under:

For SC/ST/ PwBD candidates	Intimation Charges of Rs. 85/ - +Transaction Charges + GST
For all other candidates	Application Fee -cum-Intimation Charges of Rs. 700/ - + Transaction Charges + GST

The application form is integrated with the payment gateway and the payment process can be completed by following the

- The payment can be made by using Debit Cards (RuPay/ Visa/MasterCard/Maestro), Credit Cards, Internet Banking, Cash Cards/ Mobile Wallets.
- After submitting your payment information in the online application form, PLEASE WAIT FOR THE INTIMATION FROM THE SERVER. DO NOT PRESS BACK OR REFRESH BUTTON IN ORDER TO AVOID DOUBLE CHARGE.
- On successful completion of the transaction, an e-Receipt will be generated.
- Non-generation of 'E-Receipt' indicates PAYMENT FAILURE. On failure of payment, Candidates are advised to login again using their Provisional Registration Number and Password and repeat the process of payment.
- Candidates are required to take a printout of the e-Receipt and online Application Form containing fee details. Please note that if the same cannot be generated, online transaction may not have been successful.

□ Selection Procedure:

Selection of Assistant Administrative Officers will be done through a three tiered process and subsequent Pre-recruitment Medical examination.

O Phase-I: Preliminary Examination:

Preliminary Examination consisting of objective test will be conducted online. The test will have three sections (with separate timings for each section) as follows:

** English Language test will be of qualifying nature and the marks in English Language will not be counted for ranking.

O Phase-II: Main Examination:

Main examination will consist of objective tests for 300 marks and descriptive test for 25 marks. Both the objective and descriptive tests will be online. The objective test will have separate timing for every section.

Candidates will have to answer descriptive test by typing on the computer. Descriptive test will be administered immediately after the completion of the objective test.

- ** Descriptive test of English Language etc. will be of qualifying nature and the marks in English Language will not be counted for ranking.
- "Descriptive paper of only those candidates will be evaluated who qualify in the objective part of main Examination."
- LIC reserves the right to modify the structure of the examination which will be intimated through its website.
 Other detailed information regarding the examination will be given in an Information Handout which will be made available for the candidates to download along with the call letters from the LIC website www.licindia.in under "Careers".
- The minimum marks to be obtained in each Section and cut off marks for each section and in the aggregate shall be decided by LIC. Descriptive test of English Language etc. is of qualifying nature and marks in this test will not be counted for ranking. The decision of LIC in this regard shall be final and binding on the candidates. No correspondence will be entertained in this regard.

☐ Phase-III: Interview:

Marks obtained in the Main Examination only will be considered for short listing for interview.

Commensurate to the number of vacancies, LIC reserves the right to fix the minimum eligibility standards in order to restrict the candidates to be called for interview and also fix the minimum qualifying marks to qualify in the interview. Maximum Interview marks are 60 and qualifying marks for EWS, Unreserved, OBC are 30.Qualifying marks for SC /ST/PwBD candidates are 27. Candidates who do not obtain the minimum qualifying marks as decided by LIC shall be excluded from further selection process. The decision of LIC in this regard shall be final and binding on the candidates and no correspondence will be entertained in this regard.

☐ Pre-Recruitment Medical Examination:

Shortlisted candidates in final merit list will have to undergo Pre-Recruitment Medical Examination and if found medically fit, will be offered appointment.

Important Instructions :

- After applying on-line, the candidates should obtain a system generated print out of the application on A4 size paper and retain it after signing the same. Please do not send this print out to Life Insurance Corporation of India. The option for printing the online application will be available up to 15.02.2023 only.
- Candidates who are called for interview will have to submit the duly signed System Generated Print out of the On-line
 application, Receipt of fee as mentioned above and also produce original and self attested Photostat copies of all
 relevant certificates at the time of interview, failing which their candidature shall be liable to be cancelled.
- If sufficient number of candidates does not opt for a particular centre for "Online" examination, LIC reserves the right to
 allot any other adjunct centre to those candidates OR if the number of candidates is more than the capacity available for
 online exam for a centre, LIC reserves the right to allot any other centre to the candidate.
- The possibility of occurrence of some problem in the administration of the examination cannot be ruled out completely which may impact test delivery and/or result from being generated. ☐ HOW TO APPLY:

Candidates can apply online from 15.01.2023 to 31.01.2023. No other mode for application will be accepted.

Pre-Requisites for Applying Online

Before applying online, candidates should—

- (i) Candidates should scan their:
 - photograph (4.5cm × 3.5cm)
 - signature (with black ink)
 - left thumb impression (on white paper with black or blue ink)
 - a hand written declaration (on a white paper with black ink) (text given below)

ensuring that all these scanned documents adhere to the required specifications.

- Signature in CAPITAL LETTERS will NOT be accepted.
- The left thumb impression should be properly scanned and not smudged. (If a candidate is not having left thumb, (iii) he/she may use his/ her right thumb for applying.)
- The text for the hand written declaration is as follows -
 - *"I*, (Name of the candidate), hereby declare that all the information submitted by me in the application form is correct, true and valid. I will present the supporting documents as and when required.'
- The above mentioned hand written declaration has to be in the candidate's hand writing and in English only. If it is written and uploaded by anybody else or in any other language, the application will be considered as invalid. (In the case of Visually Impaired candidates who cannot write they have to get the text of declaration typed and put their left hand thumb impression below the typed declaration and upload the document as per specifications.)
- Keep the necessary details/documents ready to make Online Payment of the requisite application fee/ intimation charges.
- Have a valid personal email ID and mobile no., which should be kept active till the completion of this Recruitment Process. LIC may send intimation to download call letters for the examination etc. through the registered e-mail ID. In case a candidate does not have a valid personal e-mail ID, he/she should create his/her new e-mail ID and mobile number before applying on-line and must maintain that email account and mobile number.

Application Registration:

- Candidates satisfying the conditions of eligibility as on 01.01.2023 are required to go to the LIC's website www.licindia.in and click on the 'Careers' to open the link "Recruitment of AAO(Generalist) 2023. It redirects the candidates to the online registration page.
- To register application, choose the tab "Click here for New Registration" and enter Name, Contact details and Emailid. A Provisional Registration Number and Password will be generated by the system and displayed on the screen. Candidate should note down the Provisional Registration Number and Password. An Email & SMS indicating the Provisional Registration number and Password will also be sent.
- In case the candidate is unable to complete the application form in one go, he / she can save the data already entered by choosing "SAVE AND NEXT" tab. Prior to submission of the online application candidates are advised to use the "SAVE AND NEXT" facility to verify the details in the online application form and modify the same if required. Visually Impaired candidates should fill the application form carefully and verify/ get the details verified to ensure that the same are correct prior to final submission.
- Candidates are advised to carefully fill and verify the details filled in the online application themselves as no change will be possible/entertained after clicking the COMPLETE REGISTRATION button.
- The Name of the candidate or his /her Father/ Husband etc. should be spelt correctly in the application as it appears in (5) the Certificates/ Mark sheets. Any change/alteration found may disqualify the candidature.
