- **◆** Date of Online Preliminary Exam. : 12th March 2023 (tentative).
- **◆** Date of Online Main Exam. : 8th April 2023 (tentative).
- → Age (As on 01.01.2023): The applicant shall have completed 21 years of age (in completed years) and not more than 30 years of age (in completed years) as on 01.01.2023, i.e. candidates must have been born not earlier than 02.01.1993 and not later than 01.01.2002 (both days inclusive) as on 01.01.2023.
  - Relaxation of Upper age limit: SC/ ST 5 years, OBC 3 years, Persons With Disabilities 10 years, Others as per rules.
- Educational Qualifications (As on 01.01.2023): An applicant from Others category (Open Market) for recruitment as an Apprentice Development Officer, in both Urban and Rural area, should possess a Bachelor's Degree from a recognized University in India established under a statute/ approved for the purpose or the Fellowship of Insurance Institute of India, Mumbai.

## ☐ Eligibility Conditions :

The candidates eligible for recruitment are classified into three categories, namely, LIC Agents Category, LIC Employees Category and Others Category (Open Market).

- 'LIC Agents Category' means-
  - (i) An individual appointed or engaged by LIC Of India for the purpose of soliciting or procuring insurance business including business relating to the continuance, renewal or revival of policies of insurance pertaining to LIC Of India; OR
  - (ii) An individual who has been appointed as an agent under the Life Insurance Corporation of India (Agents) Regulations, 2017
- 'LIC Employee Category' means a confirmed whole-time salaried employee of LIC Of India belonging to Class III cadre.
- 'Others Category' means the candidate from the open market.

The applicant should have the requisite experience as on 01.01.2023 as indicated below:-

## **☐** Selection Procedure:

Selection will be made on the basis of on-line tests, followed by an interview of the candidates who qualify in the on-line test and subsequent pre-recruitment Medical examination.

Preliminary Examination consisting of objective test will be conducted online. The test will have three sections (with separate timings for each section) as follows:

#### Important Instructions :

- After applying on-line, the candidates should obtain a system generated print out of the application on A4 size paper and retain it after signing the same. Please do not send this print out to Life Insurance Corporation of India. The option for printing the online application will be available up to 15.02.2023 only.
- Candidates who are called for interview will have to submit the duly signed System Generated Print out of the On-line
  application, Receipt of fee as mentioned above and also produce original and self attested Photostat copies of all
  relevant certificates at the time of interview, failing which their candidature shall be liable to be cancelled.
- If sufficient number of candidates does not opt for a particular centre for "Online" examination, LIC reserves the right to allot any other adjunct centre to those candidates OR if the number of candidates is more than the capacity available for online exam for a centre, LIC reserves the right to allot any other centre to the candidate.
- The possibility of occurrence of some problem in the administration of the examination cannot be ruled out completely which may impact test delivery and/or result from being generated. In that event, every effort will be made to rectify such problem, which may include movement of candidates, delay in test. Conduct of a re-exam is at the absolute discretion of test conducting body. Candidates will not have any claim for a re-test. Candidates not willing to move or not willing to participate in the delayed process of test delivery shall be summarily rejected from the process.

# ☐ HOW TO APPLY:

Candidates can apply only online from 21.01.2023 to 10.02.2023 and no other mode of application will be accepted.

## Pre-Requisites for Applying Online

Before applying online, candidates should—

- (i) Candidates should scan their:
  - -photograph (4.5cm × 3.5cm)
  - signature (with black ink)
  - left thumb impression (on white paper with black or blue ink)
  - a hand written declaration (on a white paper with black ink) (text given below)
  - ensuring that all these scanned documents adhere to the required specifications.
- (ii) Signature in CAPITAL LETTERS will NOT be accepted.
- (iii) The left thumb impression should be properly scanned and not smudged. (If a candidate is not having left thumb, he/she may use his/ her right thumb for applying.)
- (iv) The text for the hand written declaration is as follows -
  - "I, \_\_\_\_\_ (Name of the candidate), hereby declare that all the information submitted by me in the application form is correct, true and valid. I will present the supporting documents as and when required."
- (v) The above mentioned hand written declaration has to be in the candidate's hand writing and in English only. If it is written and uploaded by anybody else or in any other language, the application will be considered as invalid. (In the case of Visually Impaired candidates who cannot write they have to get the text of declaration typed and put their left hand thumb impression below the typed declaration and upload the document as per specifications.)
- (vi) Keep the necessary details/documents ready to make Online Payment of the requisite application fee/ intimation charges
- (vii) Have a valid personal email ID and mobile no., which should be kept active till the completion of this Recruitment Process. LIC may send intimation to download call letters for the examination etc. through the registered e-mail ID. In case a candidate does not have a valid personal e-mail ID, he/she should create his/her new e-mail ID and mobile number before applying on-line and must maintain that email account and mobile number.

## ■ Application Registration:

- (1) Candidates satisfying the conditions of eligibility as on 01.01.2023 are required to log in to the LIC's website <a href="https://licindia.in/Bottom-Links/careers">https://licindia.in/Bottom-Links/careers</a>. It redirects the candidates to the online registration page. A candidate can apply under multiple categories (i.e. Others category (Open Market), LIC Agents Category or LIC Employee Category) subject to eligibility criteria prescribed for that particular category with regard to age/ qualification/ experience.
- (2) To register application, choose the tab "Click here for New Registration" and enter Name, Contact details and Emailid. A Provisional Registration Number and Password will be generated by the system and displayed on the screen. Candidate should note down the Provisional Registration Number and Password. An Email & SMS indicating the Provisional Registration number and Password will also be sent.
- (3) In case the candidate is unable to complete the application form in one go, he / she can save the data already entered by choosing "SAVE AND NEXT" tab. Prior to submission of the online application candidates are advised to use the "SAVE AND NEXT" facility to verify the details in the online application form and modify the same if required. Visually Impaired candidates should fill the application form carefully and verify/ get the details verified to ensure that the same are correct prior to final submission.
- (4) Candidates are advised to carefully fill and verify the details filled in the online application themselves as no change will be possible/entertained after clicking the COMPLETE REGISTRATION button.
- (5) The Name of the candidate or his /her Father/ Husband etc. should be spelt correctly in the application as it appears in the Certificates/ Mark sheets. Any change/alteration found may disqualify the candidature.
- (6) Validate your details and Save your application by clicking the 'Validate your details' and 'Save & Next' button.
- (7) Candidates can proceed to upload Photo & Signature as per the specifications.
- (8) Candidates can proceed to fill other details of the Application Form.
- (9) Click on the Preview Tab to preview and verify the entire application form before FINAL SUBMIT.
- (10) Modify details, if required, and click on 'FINAL SUBMIT' ONLY after verifying and ensuring that the photograph, signature uploaded and other details filled by you, are correct.
- (11) Click on 'Payment' Tab and proceed for payment.
- (12) Click on 'Submit' button.
- (13) The list of examination centre for preliminary & main examination is given in previous page.

### Mode of Payment:

Candidates should make the payment of requisite fees/ intimation charges through the ONLINE mode only: The application form is integrated with the payment gateway and the payment process can be completed by following the instructions.

The payment can be made by using Debit Cards (RuPay/Visa/MasterCard/Maestro), Credit Cards, UPI, Internet Banking, IMPS, Cash Cards/ Mobile Wallets. After submitting your payment information in the online application form, PLEASE WAIT FOR THE INTIMATION FROM THE SERVER. DO NOT PRESS BACK OR REFRESH BUTTON IN ORDER TO AVOID DOUBLE CHARGE. On successful completion of the transaction, an E-receipt will be generated. Non-generation of 'E-receipt' indicates PAYMENT FAILURE. On failure of payment, Candidates are advised to login again, using their Provisional Registration Number and Password and repeat the process of payment. Candidates are required to take a printout of the E-receipt and online Application Form containing fee details. Please note that if the same cannot be generated, online transaction may not have been successful.

#### □ Note:

- In case the left thumb impression or the hand written declaration is unclear / smudged the candidate's application may be rejected.
- After uploading the left thumb impression / hand written declaration in the online application form candidates should check that the images are clear and have been uploaded correctly. In case the left thumb impression or the hand written declaration is not prominently visible, the candidate may edit his/ her application and re-upload his/ her thumb impression / hand written declaration, prior to submitting the form.
- After registering online candidates are advised to take a printout of their system generated online application forms
